1. No Kings: what's the point of mass demonstrations?

If anyone tries to tell you that mass demonstrations are pointless and don't accomplish anything, you can gently remind them of the following:

- Mass demonstrations puncture Trump's aura of invincibility by showing that there is a strong counter-force of millions of determined resisting Americans, and that counter-force is only getting stronger and larger. Individuals and organizations, the "pillars of society," who are considering knuckling under to Trump are forced to reckon with the resistance and can (and do) change course. Trump's grasp on power is NOT inevitable and CAN be countered -- and mass demonstrations show this!
- Mass demonstrations strengthen ties among individuals and activist organizations, building the infrastructure of resistance that can then be employed in future and different actions, and giving everyone the energy and the courage to persist. Look at how the George Floyd protests in Minneapolis set the stage for their awe-inspiring resistance to ICE this winter. Courage is contagious.
- Mass demonstrations bring in loads of new members -- even just passersby -- who want to join in and are guided into further action, growing the movement, and bringing us closer to success.

CISCOMANI ISSUES OF THE WEEK

- **Veterans for Mendoza:** Our team has created an alliance with Veterans for Mendoza. According to Bill Swan (bnswan@newmex.com), vets are “disgusted” by the illegal war in Iran, and the way in which Ciscomani pretends to care about service members and veterans, but actually votes for policies and actions that cut VA benefits and put service members at risk. By contrast, “Mendoza is an authentic, down-to-earth Marine veteran who understands veterans’ perspective.” Veterans for Mendoza is welcoming allies from ITAA. If you are a vet, and would like to support messaging to unseat Ciscomani, contact Bill Swan at the email above. There is an in-person meeting on March 25, and Bill can let you know how to participate.
 - **The War in Iran:** Spineless Juan issued a press release indicating his support for the attack on Iran. Did he raise concerns about lack of Congressional authorization? NO. Did he express reluctance to support potential involvement in an unending military action? OF COURSE NOT. Did he even attempt to poll his constituents to find out what we think? IT DOESN'T MATTER TO HIM. And – as someone who claims to be a big supporter of the military - did he express concern that his constituents who are in the military may be placed in harms way by this “war of choice”? NOT A BIT.
 - **Homeland Security Shutdown:** Juan continues to act clueless about why the Democrats won't continue funding ICE in its current form. He claims to be concerned about TSA payments, but his Republican colleagues voted down a Democrat proposal to separate TSA from the rest of the Homeland Security shutdown. Juan: Do you believe that ICE officers should be un-badged and masked, unlike any other type of law enforcement? Do you

believe that ICE should be allowed to conduct warrantless searches and renditions, unlike any other type of law enforcement? Whatever you really believe, you are too spineless to say anything that Trump may disagree with.

- **ESA Vouchers in Arizona:** Juan and his wife have been leading advocates at the state and national level for “school choice”. What a boondoggle!! We know that Ciscomani has 6 kids who are eligible for ESA awards which if received would total about 45K per year. We can’t confirm whether he has received these, however, because when the AZ legislature passed the law (with his wife’s lobbying) they specifically exempted US Congresspeople from public disclosure.
